

Tug and Small Commercial Vessel Licence Application



Licence to Operate a Tug or Small Commercial Vessel in the Area of the Medway Statutory Harbour Authority

The power to license Tugs and Small Commercial Vessels is in accordance with Part II, Section 11 of the '**Medway Ports Authority Act 1973**', which states -

Power to license tugs, etc.

- 1) (a) The Authority may from time to time license such number of tugs belonging to any person for such period and on such terms and conditions as they think fit.
- (b) The Authority may charge a fee not exceeding five pounds for the granting of a licence under paragraph (a) of this subsection.
- 2) (a) It shall not be lawful otherwise than in emergency for any person to use or employ any tug for moving vessels within the port unless there is in force in relation thereto a licence granted under paragraph (a) of subsection (1) of this section.
- (b) Any person who contravenes the provisions of this section shall be liable on summary conviction to a fine not exceeding one hundred pounds.
- 3) In this section "tug" means **any vessel** other than a vessel of five tons gross or less.

The requirement to Licence Tugs and Small Commercial Vessels is contained within the Guide To Good Practice On Port Marine Operations, part of the '**Port Marine Safety Code**'. In Section 10.1.2 C it states

'The authority should ensure that harbour vessels or craft which are used in the harbour are fit for purpose and that crew are appropriately trained and qualified for the tasks they are likely to perform.'

If you or your organisation operate any vessel within the Medway and Swale area for commercial purposes you must apply for a licence on the enclosed form. Once completed please email the form to richard.webb@peelports.com along with copies of all supporting documents. If you operate more than one vessel, a separate 'Details of Vessel' sheet needs to be completed for each.

2 Vessels Certification

Peel Ports as the Harbour Authority will accept any of the below certification as confirmation that the vessel is fit for purpose –

- Documentary evidence that the vessel is a registered sea going vessel, in class for the purpose that the licence is applied for.
- An appropriate Certificate of Compliance with the Workboat/SCV Code issued by an MCA recognised Certifying Authority
- An appropriate Licence issued by the Port of London Authority

If the above documentation is not held **or is not provided**, a licence will only be issued after inspection of the vessel by an Officer of the Harbour Authority. A fee will be charged for this service.

3 Insurance

A copy of the vessel's insurance certification must be provided.

4 Manning

Please complete the List of Master's (Annex 2)

A copy of all Master/Skipper's qualifications must be provided

NB It is the operator's responsibility to ensure all crew are suitably qualified and medically fit for their duties.
