## **Great Yarmouth Port Company - Bunkering Code**

Masters of bunker receiving vessels, Masters of bunker delivery vessels or lorry tanker drivers, are advised that all bunker operations within the area of jurisdiction of the Port Company, must be carried out in compliance with the Company's Bunker Code as follows:

- Approval for the transfer must be received from the port/berth operator.
- The GYPC 'Notification of Bunker Transfer' form must be completed by the receiving vessel and returned to Local Port Services prior to commencement of operations.
- Before bunkering operations start, Masters must ensure the following:
  - Overside scuppers are blocked and drip trays in place under hoses connections and other precautions to avoid overside discharge.
  - Transfer hose and manifold connections are properly made and hoses of adequate length allowing for possible movement of the vessel due to passing ships.
  - An agreed communication is set up between the ship and the bunker vessel or road tanker and that the operation is continually monitored.
  - All vessels must be adequately moored and fendered.
  - Local Port Services must be advised on VHF channel 12 prior to commencing transfer and again on completion, and vessels must monitor channel 12 while transfers are taking place.
- In the event of spillage, every action must be taken to prevent oil entering the water. The operation must be stopped and Local Port Services informed.
- Bunker operations will only be permitted in suitable weather and other conditions. GYPC may order
  cessation of the operation at its discretion and such an order must be complied with immediately
  and for which the Port Company will not accept any responsibility or liability whatsoever.
- The Harbour Master, of designated officer may board the vessel to inspect the operation at any time.
- Vessels must display the appropriate signals while transferring bunkers as described in Section 8 of the Dangerous Substances in Harbour Areas Regulations 1987, i.e.
  - By day: A red flag, International Code flag "B".
  - By night: An all-round red light.
- Only approved contractors may carry out bunker transfers. All non-approved contractors must seek approval from GYPC prior to carrying out bunker transfers.
