Conditions of Consent:

1. The Tow Master shall be responsible for producing to MDHC the RAMS & passage plan and ensure the safety of the tow. The planning should be carried out in line with the Port of Liverpool Towage Guidelines and any other pertinent legislation.
2. Consent to conduct the Dead Tow Operation shall be granted based on the system of work described in the project plan.
3. All dead ship & pilotage compulsory tows are subject to a consultation with an Authorised Pilot at a minimum of 48 hours' notice prior to the commencement of the tow.
4. All dead tows highlighted within this application are subject to consent approval from the Harbour Master at a minimum of 24 hours' notice prior to the commencement of the tow.
5. Notwithstanding Dead Tow Consent being given, the Harbour Master (or his appointed officer) may at any time instruct that the Towage Operation is suspended.
6. Dead Tow consent does not constitute a permit to work.
